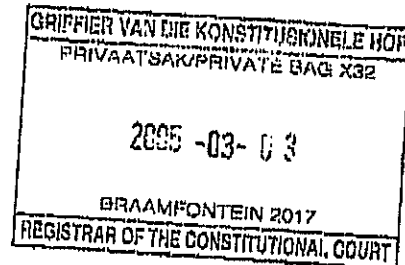
DIRECTIONS DATED 03 MARCH 2005

1. The applicant is admitted as an amicus curiae.
2. The amicus will be entitled to address oral argument at the hearing in support of the submissions lodged by it on 28 February 2005 dealing with the single exit price. Thirty minutes will be allowed for this purpose immediately following the argument of counsel for the applicants in the main application. The amicus must not repeat arguments that have already been addressed to the court by counsel for the applicants.

3. If the amicus intend to rely on evidence alleged to be admissible in terms of rule 31(1), it must lodge notice of its intention to do so by 7 March 2005. Any party objecting to such evidence may lodge an objection thereto. Such objection shall be lodged by 11 March 2005, and must contain sufficient particularity to enable the Court to determine whether or not the evidence falls within the terms of rule 31(1).
